9. IP telephony: Terms and Conditions

1. All prices quoted are exclusive of GST. 2. In order to access the service, you may need a dedicated fixed line broadband Internet connection, such as ADSL2. You will also need an IP phone and may need extra hardware depending on your set up, e.g. router and switches. 3. We recommend that the Service be accessed with hardware supplied or approved by us, using a broadband ADSL or SHDSL service supplied by us to our specifications. Additional charges will apply if we provide support on customer provided hardware and support on customer supplied hardware will be best effort only. 4. The broadband speed required for the Service will depend largely on your network demands. Data transmission demands on your network may cause the bandwidth available for voice transmission to be limited if voice and data share the same connection. 5. Extra charges will be incurred for freight for any hardware. 6. Porting is charged per end user site (see: PAF – Port Authorisation Form). 7. International Calls are allowed by default; if you require this feature to be blocked, please contact Tropical Business Solutions Pty Ltd trading as Tropical Communications support or your account manager. 8. Early termination fees will apply to a minimum term agreement; if you cancel your service prior to the end of your contract term, you must give us 30 days' notice and you will incur an Early Termination Fee (ETF) equal to your minimum monthly commitment as per your agreement with us multiplied by the months remaining in your contract. 9. The minimum term will commence upon the later of i) when your application is accepted by us; or ii) when your services are connected. 10. Fair Use Policy applies. 11. All hardware leased is to be returned in the same condition it was leased to you. Where phones have been damaged, you will be responsible for its replacement cost (\$400 for the reception desk phone, \$200 for the standard desk phone, \$300 for the cordless phone & docking stations, \$850 for the conference phone). 12. If at the end of the lease term you don't return the leased asset, we will charge you for the full outright cost of the handsets (\$400 for the reception desk phone, \$200 for the standard desk phone, \$300 for the cordless phone & docking stations, \$850 for the conference phone). We can retrieve handsets for you at the end of the term, however labor costs associated with this will be at your cost (\$130+GST per hour). 13. We will continue to charge the monthly rental fee even when the contract has finished until a new contract is established or the handsets are returned to Tropical Business Solutions Pty Ltd trading as Tropical Communications & BlueReef Communications.
